## Location Allowance for Nursing Grades Agreement on the Implementation of new arrangements in relation to payment of Location Allowance to Nurses working in recognised areas

- I am directed by the Minister for Health and Children to refer to the review of the application of the location allowance recently completed. This review was undertaken in the context of paragraph 7 of the Agreement on the implementation of new arrangements in relation to payment of the Location Allowance to Nurses working in recognised areas.
- 2. I am to convey sanction for the application of the Location Allowance to nurses working in dedicated Care of the Elderly¹ and Alzheimers Units in both Mental Health Services and the Intellectual Disability Sector with effect from 1 January 2004.
- 3. Nurses up to and including Clinical Nurse Manager II level working in Psycho-geriatric Wards, Elderly Mentally Infirm Units, Alzheimers Units, Psychiatry of Later Life Services and Care of the Elderly Services are eligible for payment of the location allowance. Appendix A contains a full list of areas eligible for the location allowance.

- 4. The location allowance must be discontinued when nurses move from qualifying areas or are promoted above Clinical Nurse Manager II level. Pro-rata arrangements apply to jobsharing and part-time staff.
- 5. Managers are reminded of the importance of adhering to national agreements on the payment of allowances. The location allowance may only be paid to staff working in units listed in Appendix A.
