Staff who are on-call / standby but *away* from workplace are entitled to a payment of £180 per 24-hour period (pro-rata) together with the usual call-out payment. Staff who are on-call / standby *at* their workplace are entitled to a payment of £270 per 24-hour period (pro-rata) together with the usual call-out payment. If such staff are required to work the additional exceptional premia rates apply.
