I am directed by the Minister for Health and Children to refer an agreement reached as a result of negotiations between the Department of Health and Children, the Health Service Employers Agency and IMPACT, the following has been agreed:

It is agreed that a salary scale based on a differential of £1,750 p.a. (in 1st. April 2000 terms) over Principal Social Worker will apply to those positions heretofore know as Head Social Worker in the ERHA, which previously enjoyed a pay differential over Senior Social Worker, and to those Social Worker positions in voluntary organisations which were traditionally graded above the Senior Social Worker level. Assimilation will be by corresponding points with effect from 1st. April 2000.

In order that your non-capital allocation may be adjusted to take account of the costs involved, you are asked to complete costing forms (Appendices I & II) to reflect the funding required.
