

Shaping a Healthier Future

Re: Remuneration of Basic Grade Inviconmental Health Officer under the Programme for Competitiveness and Work

It has come to the attention of the Department that a number of anomalies have arisen in the pay scale of basic grade Environmental Health Officers. These anomalies have arisen as a result of inconsistencies in the application of the assimilation process on the phased removal of the first point of the Environmental Health Officer scale on the 1st June 1998, 1999 and 2000.

On the first of June in each of three years and in the year 2001, when the bottom point of the Environmental Health Officer scale will also be removed, assimilation should be as follows:

Officers should be assimilated to the new scale on the basis of corresponding point, after the removal of the first point of the scale. This would mean that, in the example of the scale below for 1st June 2000, an officer on the fifth point on 1st April 2000 (£23,141) would be assimilated to the fifth point of the new scale (£24,065).
