## Retrospection Payments for Director of Nursing/Matron, Bands 3, 4, 5 Hospitals

Dear Chief Executive / Secretary/Manager,

I am directed by the Minister for Health and Children to refer to Labour Court Recommendation No. 16011 and to Circular 14/99, dated 4th February 1999.

As indicated in previous Circulars, nursing unions had argued that, in a limited number of instances in Bands 3, 4, and 5 hospitals, residual problems remained with regard to the implementation of the arrangements whereby Directors of Nursing/Matrons and Chief Nursing Officers who were in receipt of premium payments for weekend, bank holiday or night attendance would terminate the practice in accordance with the provisions of the PCW Agreement.

In accordance with the terms of this Recommendation, I am to convey sanction to the payment of retrospection for Director of Nursing/Matron in Bands 3, 4, 5 Hospitals, with effect from 1 June 1997. The increase only applies to basic salary. Revised salary scales are attached at Appendix 1.

Arrangements should now be put in place to terminate the practice of additional payment for weekend, bank holiday and night allowance in accordance with the provisions of the PCW Agreement, where such arrangements are not yet normal practice.

The costs involved are to be met from within your existing financial allocation.
